Antidiscrimination is today the main paradigm, and perhaps the symbol itself, of the process of European integration. Apart from having played a fundamental role in the history of the relationships between EU and Member States, as well as in the establishment of primacy of EU law and in the shaping of a 'social' and right sensitive EU, the principle of antidiscrimination is a code that embraces a set of ideas and public expectations concerning the role and the activities of public powers, the relation between public powers and individuals and among individuals themselves. This meeting is dedicated to discuss the complex – often ambiguous, ever challenging – narrative of antidiscrimination.
