Professor Francesco Seatzu is a Member of the Doctoral School of International and EU Law of the State University of Milano since 2007, of the CIDOIE (Centro Interuniversitario sul Diritto delle Organizzazioni Internazionali Economiche), of the Italian Society of International Law. He is a member of the Board of Editors of *Revue des Droits de l'Homme*, *European Papers*, *Cuadernos de Derecho Transnacional*, *Revista electrónica Iberoamericana* and *Diritto Pubblico Comparato e Europeo*. Moreover, he has also been a member of the Board of Editors of the *Journal of Private International Law*.

His research interests include international economic law, private international law, international dispute settlement, as well as international institutional law, with a particular focus on international financial institutions and the European Union. Such a variety of interests is mirrored in his publishing records which counts three monographs (one co-authored with Marco Odello), seven edited books and more than 100 articles, published in international and national journals and renowned edited volumes.
