Simona Iammarino is Professor of Applied Economics at the Department of Economics and Business, University of Cagliari, Italy, and Visiting Professor at the Department of Geography & Environment, London School of Economics and Political Science, UK. She was Professor of Economic Geography at the LSE (2009-2022), where she acted as Head of Department (2014-2017) and academic member of the LSE Council (2016-2020). Simona has been an affiliate faculty member at the Gran Sasso Science Institute (GSSI) – Social Science, L'Aquila, Italy, since 2016, and member of the Board of the LSE-Cañada Blanch Centre since 2021. She was elected Fellow of the Academy of Social Sciences (FAcSS) and Fellow of the Regional Studies Association (FeRSA) in 2017, and Fellow of the Royal Society for Arts, Manufactures and Commerce (FRSA) in 2018. She was appointed member of the Board and Executive Group of the Regional Studies Association (RSA) in November 2020.

Her main research interests lie in the following broad areas: Multinational corporations, globalisation processes and regional and local impacts; Economic geography of innovation and technological change; Regional and local economic development and policy.

Simona is co-editor of the *Journal of Economic Geography*, and was co-editor of *Regional Studies* (2008-2013). She is currently the Chair of the *RSA Journal Committee*. She has published more than 70 articles in major peer-reviewed journals, around 30 book chapters, and numerous working papers, policy reports and other publications. She co-authored two books widely cited in the literature: *Multinational Corporations and European Regional Systems of Innovation* (with J.A. Cantwell, 2003), and *Multinationals and Economic Geography. Location, Technology, and Innovation* (with P. McCann, 2013). She has a long-term experience, both as Principal Investigator and as Senior Researcher, in externally funded international research projects, and in consultancy projects for various international organisations (e.g. EU Commission, OECD, United Nations, WIPO) and government agencies.
