(funded by the MUR with Notice of Excellence Departments 2023-2027 (l. 232/2016, art. 1, paragraphs 314 – 337))
Application deadline: 9th June 2026 - 1:00 p.m. (local time)

The Department of Electrical and Electronic Engineering (DIEE) of University of Cagliari has been recognized by the Ministry of Universities and Research as Department of Excellence 2023-2027.

One of the objectives of the higher qualification teaching activities of the DIEE Excellence project, funded by the MUR with Notice of Excellence Departments 2023-2027 (l. 232/2016, art. 1, paragraphs 314 - 337), is to enhance the third-level educational offer by providing one-month positions for Visiting Professors or Scientists.

The stay of the Visiting Professor/Scientist has the purpose of:

- providing opportunities for teaching and research activities;
- enhancing the teaching and research profile of UniCa;
- starting long-term collaborations with other Universities or Research Centres both inside and outside Europe.

AVAILABLE POSITIONS

In order to achieve the above-mentioned objectives, our VPS Programme 2025 is going to appoint professors and researchers divided into two different categories:

- Professors/researchers or internationally renowned professionals (e.g., architects, engineers, jurists, intellectuals, etc.) involved in teaching – including seminars - and research activities autonomously: **6 visits of 1 month (long visits) (type B.1)**
- Professors/researchers or internationally renowned professionals (e.g., architects, engineers, jurists, intellectuals, etc.) involved in teaching – including seminars - and

research activities autonomously: **5 visits between 6 and 10 continuous days** (short visit) (**type B.2**)

All visits must be completed **by 30th September 2027**.

VPS PROFILES

Academic scholars, including *emeriti* professors, employed in foreign Universities, institutions, or research centres, and internationally renowned professionals (e.g., architects, engineers, jurists, intellectuals, etc.), even if they are not tenured at universities or foreign research centers. Candidates who were appointed as VPSs at UniCa in the 2023/2024/2025 edition and completed their stay are excluded.

In order to be selected, candidates cannot have other contracts with UniCa simultaneously with their appointment as VPS.

Furthermore, in order to avoid cases of nepotism and conflict of interests, VPSs with a relative within the 4th degree by consanguinity (blood) or affinity (marriage or adoption) working at UniCa as Professor of the Department presenting the VPS's application, including the Rector, the General Director or a member of the University Board of Directors, are excluded¹.

DIEE and UniCa reserve the right to check candidates' affiliations and the truthfulness of the information provided. Applications incompatible with the selection criteria will be rejected.

DEADLINE AND HOW TO APPLY

Application deadline: 9th June 2026 - 1:00 p.m. (local time).

This selection procedure is addressed to researchers and professors of the Department of Electrical and Electronic Engineering (DIEE) of the University of Cagliari, belonging to the scientific disciplinary sectors (SSD) IIET-01/A, IIND-08/A, IIND-08/B, IINF-02, IINF-04/A, IINF-05/A, IBIO-01/A, who are interested in inviting scholars who can contribute to the development of the educational offering and the internationalization process included in the DIEE Excellence project.

Professors or Researchers of DIEE who are interested in hosting a Visiting Professor/Scientist are required to submit an application to DIEE by completing the dedicated online application form available on the Visiting Professor/Scientist DIEE Excellence 2025 Program page of the University's official website. Applications may be submitted from the date of publication of this call until 1:00 p.m. (local time) on **June 9th, 2026**. After this deadline, the system will no longer permit the completion or submission of the electronic form.

Each application must include the following information:

1. full name of the proposing DIEE member;
2. full name of the proposed visiting professor/scientist;
3. academic title of the visiting professor/scientist;
4. home institution of the visiting scholar, indicating any existing agreements or collaborations with the University;
5. description of the teaching and research activities to be carried out by the visiting scholar;
6. duration of the visit (long/short) and number of days required in the case of a short visit (from 6 to 10) - only for type B.2 visits;
7. proposed period of activity.

Incomplete application forms will result in exclusion from the selection process. The following documents must be uploaded at the time of submission:

- a dated and signed curriculum vitae of the visiting scholar, written in either Italian or English (maximum 4 pages, 1MB, PDF format), highlighting the most relevant publications of the candidate;
- a clear, legible copy (front and back) of a valid identity document of the visiting scholar, with a visible photograph.

Applicants may also upload any additional documentation deemed useful for the evaluation of the candidate's academic and scientific profile, using the designated section of the online form.

With regard to point 7), applicants should note that, **for scholars from outside the European Union, at least four months** are generally required to obtain a visa from the start of the procedure.



Upon successful submission of the application, the system will send a confirmation email to the address provided in the form, serving as an official receipt.

The aforementioned documents constitute an integral part of the application and must be submitted simultaneously. Subsequent submission by email will not be accepted. The responsible Office will verify the accuracy and completeness of the documentation and will exclude any applications that do not comply with the criteria set forth in this call. The Office reserves the right to request additional documentation at any stage of the evaluation process.

SELECTION PROCESS AND EVALUATION OF QUALIFICATIONS

The Department will appoint a Selection Committee responsible for evaluating the submitted applications. The Committee, appointed by a Decree of the Department Head, must be composed of at least three faculty members affiliated with the Department.

The Committee will first verify that each application meets the eligibility requirements set out in this Call for Applications (Articles 1 and 2), and will then proceed to evaluate the applications based on the criteria approved by the Academic Bodies during the meetings held on June 26 and June 30, 2025 and according to approved decision on the Department Council meeting held on 18 July 2025:

- a) Curriculum vitae of the candidate for the VPS position (academic background and professional experience), and the international standing of the invited scholar;
- b) Documented teaching and research activity, including publications;
- c) International reputation of the candidate's home university, research institution, or organization;
- d) Impact of the visit on student training programs and DIEE research projects;
- e) Consistency between the academic profile of the proposed scholar and the planned activities.

In the case of candidates who have previously served as Visiting Professors at UniCa, the assignment will take into account the results of the evaluation conducted at the end of their previous visit.

The Committee will draw up a ranking list by assigning scores based on each criterion.

The ranking will subsequently be submitted for approval to the Department Council.



The approval of the applications will take place through the Department Head's Order, taking into account the rankings submitted by the Departmental Commission and the available budget. Priority will be given to faculty members who did not receive Visiting Professor/Scientist assignments under the 2023/2024/2025 calls.

Visiting appointments will not be funded if the scholar arrives before the full selection procedure is completed.

NOTIFICATION OF AWARD AND ACCEPTANCE OF APPOINTMENT

The final list of selected Visiting Professors will be published on the DIEE website, and the selected candidates will be formally notified by email of their appointment.

The competent Office will send the winners a *confirmation form*, which must be filled in and returned via email by the deadline indicated in the form.

Any appeals must be submitted to the Responsible Officer for the procedure within 5 calendar days from the date of publication on the website.

The approved period of activity must be spent entirely at UniCa. Leaving the host institution is allowed only in exceptional cases, and only after notifying the Office via email.

Where appropriate, Visiting Professors/Scientists may carry out some activities at external campuses of the University.

Non-EU Visiting Professors must plan their arrival at least 4 months in advance, taking into account the time required to obtain an entry visa to Italy, which is mandatory to carry out paid academic activities at UniCa.

REMUNERATION AND EMPLOYMENT CONTRACT

Type B.1 – long visit

Remuneration for **long visits (1 month)** of academic scholars, including *emeriti* professors, employed in foreign Universities, institutions, or research centres, is based on the correspondence of the candidate's academic qualification to the Italian Academic position:

- EUR 5,626.10/month (gross) for a full/associate professor (or equivalent according to the Italian academic system);
- EUR 4,021.11/month (gross) for a researcher (or equivalent according to the Italian academic system);



The equivalence of the candidate's academic position to the Italian academic system will be evaluated according to the tables of the [Italian Ministerial Decree no. 662 of 1st September 2016](#).

Remuneration for **long visits (1 month)** of proven internationally renowned professionals (e.g., architects, engineers, jurists, intellectuals, etc.), even if they are not tenured at universities or foreign research centers, is based on the correspondence of the candidate's academic qualification to the Italian Academic position:

- EUR 5,626.10/month (gross) for Visiting Professor/Scientist with a position equivalent to a full or associate professor, with at least 15 years of professional experience, and possessing high-profile qualifying qualifications. Any exceptions to the 15-year requirement must be justified by the Commission, in the case of profiles of extraordinary national or international relevance;
- EUR 4,021.11/month (gross) for Visiting Professor/Scientist with a position equivalent to a researcher, with less than 15 years of professional experience;

For professionals of proven international renown, the Evaluation Committee, after examining the documents indicated in letters a), b), and d) of Article 4, determines the equivalent academic position in the Italian system to define the compensation to be awarded to Visiting Professors.

Taxes and contributions charged to the VPS's gross salary by the Italian law are the following:

- ✓ 30% (withholding tax, IRPEF, art. 24, par.1-ter of Presidential Decree no. 600/1973)
- ✓ social security contribution (INPS) on the total amount
- ✓ national insurance contribution (INAIL)
- ✓ regional and municipal additional tax.

VPSs selected for a long visit sign a self-employment contract.

VPSs selected for a short visit sign an occasional self-employment contract with UniCa.



Remuneration of **short visits** is detailed as follows:

- EUR 228.57 (gross) as a daily allowance;
- Flat-rate coverage of travel expenses:
 - EUR 600.00 (gross) for Visiting Professors coming from a European Country.
 - For Visiting Professors coming from non-European countries, the amount will be calculated based on the distance between the host institution (Cagliari) and the Visiting Professor's place of origin, as follows:
EUR 1,200.00 (gross) for distances up to 3,000 km;
EUR 1,500.00 (gross) for distances over 3,000 km.

The amounts above (daily allowance + coverage for travel expenses) are gross incomes including taxes charged to VPSs by the Italian law:

- ✓ 30% (withholding tax, IRPEF, art. 24, par.1-ter of Presidential Decree no. 600/1973);
- ✓ social security contribution (INPS) on the part of the payment exceeding EUR 5,000.

If the VPS is registered for VAT purposes as an independent contractor, he/she will be asked to provide an invoice according to the laws on VAT currently in force in Italy, the EU, and outside the EU.

As to cover a part of visa and residence permit costs, an additional flat-rate contribution of EUR 110,00 will be allocated to the non-EU VPSs, included in one of the following categories:

- Researchers selected for a long visit;
- Professors/Researchers selected for a short visit.

This additional contribution is to be considered an essential part of the VPS' payment and will be allocated upon paying the total amount.

Any other possible method of payment may be considered only in exceptional circumstances, if duly justified, and will be processed according to the relevant law currently in force.

On the basis of specific agreements with many foreign Countries to avoid double taxation on income, the University of Cagliari can apply to the VPS the most favorable tax regime. According to these agreements, both States and a single State can levy a tax on the same income.

The definite taxation can be applied in the Country where the VPS resides or, partially, by the paying Country.

For the direct application of bilateral tax treaties, the Visiting Professor/Scientist appointed by the University of Cagliari will be required to complete a specific form adopted by the Italian Revenue Agency (Agenzia delle Entrate) by provision dated July 10, 2013, which can be downloaded from the [following link](#).

Specifically, in order to request full or partial exemption from Italian income tax on income paid to non-resident individuals under international tax treaties to avoid double taxation, the **Form D – Other Income** (available in Italian, English, and French) must be completed in its entirety, including the **certificate of tax residence** issued by the relevant tax authority in the beneficiary's country of residence.

This certificate is generally valid from the date of issue until the end of the tax period indicated in the form, provided that the declared conditions remain unchanged throughout the same period.

If the certificate of tax residence is not provided by the competent foreign tax authority at the bottom of Form D, Italian tax law requires that the non-resident applicant, interested in the direct application of treaty benefits, must submit:

- the completed and signed Form D (sections relevant to the applicant), and
- a **tax residence certificate** issued by the tax authority of the applicant's country, using a specific form, confirming tax residence for the current tax year for the purpose of applying the tax treaty.

It is essential that the certificate of foreign tax residence **covers the entire period** during which the income is earned, i.e., the period of activity as a Visiting Professor/Scientist at the DIEE of the University of Cagliari. Certificates with an expiration date prior to the conclusion of the engagement cannot be accepted for the direct application of the treaty.

The required documentation, i.e., either:

1. Form D, complete with the certification by the foreign tax authority affixed at the bottom of the same form;



OR

2. Form D completed and signed in the relevant parts by the Visiting Professor/Scientist, along with the separate certificate of foreign tax residence issued by the competent foreign authority, must be sent in advance by email and then submitted in original upon the start of the activity at the University, along with other forms required by the University administration (e.g., personal, tax, social security, and banking information forms, copy of a valid ID, etc.).

If the mandatory documents (either the complete Form D with foreign certification, or the completed Form D accompanied by a separately issued certificate of tax residence) **are not submitted in original**, the treaty benefits cannot be applied directly. As a result, the income from the Visiting Professor/Scientist's activity will be subject to **a 30% withholding tax (IRPEF) at source**, as required by Articles 24 and 25 of Presidential Decree No. 600/73.

Once in possession of the necessary tax certification, the Visiting Professor/Scientist may still apply for a **refund of the IRPEF paid in Italy** by submitting a request to the **Centro Operativo Servizi Fiscali** of the **Italian Revenue Agency** in Pescara at the following address:

The request must be made using the specific form **Form D – Other Income**, available on the [website of the Italian Revenue Agency](#).

The application for reimbursement must be submitted within **48 months** from the date of the IRPEF deduction and must be accompanied by documentation proving both the deduction and the [right to reimbursement](#).

The Italian Revenue Agency will verify whether the conditions for reimbursement are met and, if so, will proceed with the refund.



PAYMENTS

VPSs will receive their payment at the end of the visit, after submitting a **final report** about the activities carried out at UniCa (countersigned by their sponsor colleague). Depending on the payroll system and the VPS's registration date at UniCa, the first payment can be postponed by one or two months: VPSs should sign their contract by the 5th of the month in order to obtain their payment at the end of the following month; otherwise, they will be paid two months later.

In case a convention to avoid double taxation is applied directly, the VPS's payment cannot be processed until the hard copies of the statements/certifications provided by the foreign fiscal authorities have been received.

Payments are credited **only to the VPS's bank account** through an international bank wire transfer. **Advanced payments are not allowed.**

DUTIES AND ACTIVITIES AT UNICA

At their arrival, VPSs will attend the referring Office to sign their contract and register their position.

VPSs should spend the whole appointed period at UniCa and are kindly invited not to leave Cagliari without a previous agreement with the DIEE office. Any possible change to their initial stay plan should be agreed with the hosting Department and the VPS Office.

VPSs are invited to attend the cultural and scientific activities organized at UniCa during their stay.

WAIVER

In case of a waiver by the winners, at the indisputable judgment of the Examining Commission, the available places for VPS will be given to the candidates classified as eligible, according to the order of the ranking.

HEALTH INSURANCE

European Citizens

EU Citizens staying in Italy for less than three months and covered by a proper national social security scheme can get all the sanitary services provided by the Italian law, showing their "European Health Insurance Card – EHIC-TEAM" (or a substitutive temporary certificate).



They will receive the same services as Italian citizens for free or under a prescription charge (Italian National Health Service “ticket”).

Non-EU Citizens

Non-EU Citizens are invited to extend their health coverage to Italy or to subscribe to a private health policy for their period in Cagliari, before leaving their Countries. Registration for the Italian National Health Service is allowed only to foreign citizens spending more than three months in Italy and applying for a residence permit.
